The goal and mission of the CAC is to support the victims, their families and the larger community by providing a coordinated investigation and comprehensive response to each child victim. Children's Advocacy Centers are child-focused, facility-based programs which collaborate with a team of professionals to investigate, prosecute and treat child abuse, both sexual and physical. Before creating this model, child victims would have to recount their experiences many times, reliving the trauma again and again. At the CAC of Southeastern Indiana, children recount their experience only once to trained, child-friendly forensic experts.
